SUBJECT: Department Leadership Upon the Presidential Inauguration on January 20, 2017

This memorandum and the attached list detail for Department of Defense personnel and organizations the names of individuals designated to serve as either "Acting" or "Performing the Duties of" for each of the Presidentially Appointed, Senate-confirmed (PAS) positions in the Office of the Secretary of Defense (OSD) and the Military Departments. These designations are effective at noon January 20, 2017, in conjunction with the inauguration of the 45<sup>th</sup> President, and are as provided for in the Federal Vacancies Reform Act of 1998, as amended (5 U.S.C. §§ 3345-3349d), and applicable Executive Orders on succession to the positions of Secretary of Defense and Secretaries of the Military Departments.

Persons on the attached list serving in an "Acting" capacity may perform all of the duties of the PAS position concerned.

Persons on the attached list serving in a "Performing the Duties of" status may perform all of the duties of the PAS position concerned, except those duties, if any, that qualify as "statutory" for purposes of the Federal Vacancies Reform Act of 1998, as amended. A "statutory" duty, also known as an "exclusive" duty, is one that by law or regulation may only be performed by the PAS Officer concerned or someone who is serving in an "Acting" capacity for the PAS Officer concerned. Such matters may be acted upon only by the Secretary of Defense or Acting Secretary of Defense. If there are questions about whether a duty is "statutory," the

Office of the General Counsel of the Department of Defense, or in the case of a Military Department its Office of General Counsel, must be consulted. In addition, persons on the attached list who are "Performing the Duties of" a PAS position, who are not themselves appointed as PAS Offices, to the extent that any duty is required by statute, regulation, or other applicable guidance to be performed by a PAS Officer, shall refer matters relating to such duty to an appropriate PAS Officer in the organization – for example, for OSD the Secretary of Defense, Acting Secretary of Defense, or Deputy Secretary of Defense, and for the Military Departments the Acting Secretary of the Military Department concerned.

The succession orders for the positions of the Secretary of Defense and the Secretaries of the Military Departments are addressed in Executive Orders. For the other listed PAS positions, this memorandum and attached list is intended to supersede succession order memoranda that are in effect before this memorandum, but only to the extent that those existing memoranda are inconsistent with this memorandum. Following the Presidential Inauguration, the relevant PAS Officer, Acting PAS Officer, or person Performing the Duties of a PAS Office may change the succession order of a specific PAS position.


